1. The name of Trust shall be "DHEERAN CHINNAMALAI CHARITABLE TRUST". The office of the Trust shall for the time being be situated at '1/2-7Molayanur,Papireddipatti Tk, Dharmapuri Dt 636 904.
2. The author hereby declares a sum of Rs.5000/- (Rupees Five Thousands only) as the Trust property and assigns, transfers and delivers the same to the Board of Trustees who shall hereinafter stand possessed of the aforesaid Trust property and funds, which expression wherever the context permits and shall hereinafter include all investments in cash or in kind or in any nature whatsoever into and for which the said property or any part thereof may from time to time be converted, varied, or exchanged and or such other investments as may be held by the Board of Trustees from time to time in relation to these presents with all incomes, thereof by using and / or investing such property upon trust for the objects set out herein and subject to the provisions and conditions hereinafter contained in these presents.
3. The author of the Trust hereby declares that the Board of Trustees shall hold the Trust properties for fulfilling the objects enshrined in the Trust Deed.
4. The author of the Trust hereby declares that the Trust so formed as above shall be **IRREVOCABLE**.
5. **OBJECTS & ACTIVITIES OF THE TRUST ARE:**
 - a) to undertake projects and steps to spread education and educational facilities and provide scholarship to deserving people;
 - b) to establish, maintain or take over and maintain, run, develop and improve and extend Nursery, Elementary, Higher Secondary, Matriculation Schools, Poly-Technics and Colleges for study of Humanities, Technical, Vocational, Professional, Workshops, Industrial Technological Institutions, and Hostels for the benefit of students

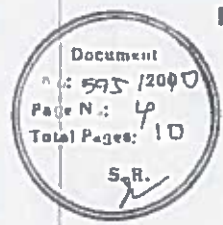

- c) to render assistance service to the handicapped, medical relief to the sick irrespective of caste, creed or community;
- d) to serve without consideration of caste, creed or nationality the needs of public health, childcare, immunisation, education, community development and harmony;
- e) to undertake projects for the upliftment of mankind in general, while undertaking projects, the Trust shall not carry on any such activity with the intention of earning profit;
- f) to give financial help, to safe guard the welfare of physically handicapped, destitutes, widows and downtrodden people;
- g) To provide food, shelter for people who are financially backward irrespective of caste, creed or community;
- g) to afford financial and free medical treatment to the poor and needy persons;
- h) to accept donations, grants, presents and gifts either in cash or in kind, loans and subscriptions for and on behalf of the Trust and to adopt all lawful courses, means and measures for raising funds for the Trust; and
- i) generally to do all such other acts, things and matters as are conducive to the general objects of the Trust, provided however that nothing shall be deemed to include any object which is not a "charitable purpose";
- j) the benefits of the Trust are available and open to all people irrespective of caste, creed, religion, sex etc., and the objects hereinabove mentioned are independent of each other and the Board of Trustees, may from time to time apply the funds of the Trust in carrying out all or any of the aforesaid objects of the Trust.

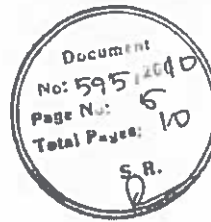

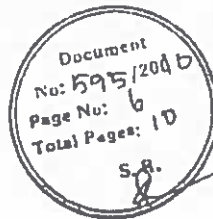

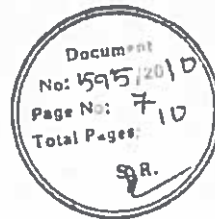

The number of members on the Board of Trustees at any time, shall not be less than THREE and shall not be more than FIFTY.

The Board of Trustees may elect a person among themselves as Managing Trustee.

- 6.2 The Board of Trustees shall meet as often as necessary to transact the business relating to the Trust .
- 6.3 The quorum for a meeting of the Board of Trustees shall be three.
- 6.4 In all matters pertaining to the Trust, the decision of the majority of the Trustees shall be final and in case of equality of votes, the Managing Trustee shall have a casting vote.
- 6.5 The properties, funds and assets of the Trust shall vest with Managing Trustee of the Board of Trustee.
- 6.6 The Managing Trustee shall have custody and control of all the documents. Accounts papers and other matters and things relating to the Trust and its properties.
- 6.7 The Managing Trustee with the prior approval of the Board of Trustees is empowered to buy or take on lease, properties in the name of the Trust for the purpose of the Trust, out of the corpus of the Trust property.
- 6.8 The Managing Trustee shall have, subject to the control, direction and superintendence of the Board of Trustees, all powers for the purpose of administering the affairs of the Trust and the institutions and establishments owned, run or conducted by the Trust.
- 6.9 The Trustees shall be kept fully indemnified by the Trust against any action or claim or loss suffered or liability arising against them on account of anything done by them in good faith pursuant to the powers and authority conferred on them by these presents.
- 6.10 Any two of the members of the Board of Trustees shall jointly open current or deposit accounts in the name of the Trust in any bank or banks, as the Board of Trustees may decide from time to time and operate the same jointly or through any person authorised by the Board of Trustees . The Managing Trustee shall arrange for the maintenance of correct and proper accounts of the receipts and payments of the Trust and the assets and liabilities of the Trust.
- 6.11 The accounts of the Trust shall be closed for the first time on 31st March and thereafter on the 31st March of every year, and Income and Expenditure account for the year ended and Balance Sheet as at that

date shall be audited by a Chartered Accountant appointed by the Board or Trustees on such remuneration as they may decide.

- 6.12 Within SIX months after the close of the accounting year, the Board of Trustees shall place the said audited Balance Sheet as at 31st March and the Income and Expenditure account for the year ending 31st March immediately preceeding.

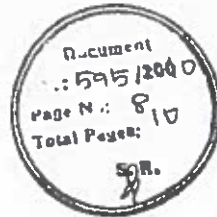
7. INVESTMENTS:

The funds of the Trust shall be invested as may be decided by the Board of Trustees from time to time in the name of the Trust either in securities authorised by the Indian Trust Act and/or in Scheduled Banks as authorised under the Income Tax Act and/or in purchase or construction of Land and Buildings or such other investments as may be authorised under the Income Tax Act from time to time.

8. POWERS OF THE BOARD OF TRUSTEES:

- 8.1 The Board of Trustees shall have the power to vary any investments already made either by sale, exchange or otherwise.
- 8.2 It is open to the Board of Trustees to co-opt or remove any one or more members as Trustees by the approval of the majority of the existing Board.
- 8.3 The Board of Trustees shall have powers to acquire as well as to dispose off immovable properties. In such cases under specific resolution of the Board, the Managing Trustee and another Trustee duly authorised shall jointly represent the Board, and execute required documents or get the required documents executed by the Board on behalf of the Board of Trustees.
- 8.4 The Managing Trustee shall have power and authority to delegate any of his or her powers to any member or members and constitute any committee or standing committee for specific purposes by passing special resolution in that regard.
- 8.5 The Board of Trustees are empowered to borrow monies towards achieving the objects of the Trust. Any two Trustees shall sign the required documents jointly for this purpose.
- 8.6 The Board of Trustees shall have powers to frame rules and/or byelaws in order to carryout the objects of the Trust and to after / amend such rules and/or byelaws whenever they deem it necessary and also to constitute committees for any of the purposes of the Trust.

8.7 To accumulate funds, invest funds not immediately required in deposit with nationalized banks or other public financial institutions like Unit Trust of India, I.D.B.I. etc., and or in accordance with the Rules and provisions contained in Sec.11 and 13 of the Income Tax Act, 1961 as amended from time to time.

8.8 To merge or amalgamate with any Trust formed with similar object.

OTHERS :

9. The Trust shall not carry out any activities outside India and prima facie shall be within India only.

10. The Trust shall sue or be sued in the name of the Managing Trustee.

11. The Trust shall not carry on any activity with the intention of earning profit.

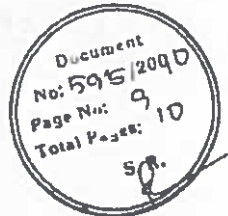
12. The income and funds of the Trust shall solely be utilised towards the objects and no part of it shall be utilised for payment to Trustees/Members by way of profit, interest, dividends and the like.

13. Where the trust be terminated for any reason, the balance in the trust fund shall be used by Board of Trustees for donation to any other charitable trust or institution with similar objects.

14. Amendments/changes to any of the aforesaid clauses of the trust deed can be made only after obtaining the prior approval of Commissioner of Income-Tax.

15. The provisions of the Indian Trust Act, 1882 shall apply to all matters not specifically mentioned in these presents.
